This Contract is entered into on the _____ day of _____, 20____, by A Place to Call Home, Inc. Parrot Rescue and Adoption ("APTCH") and _____ (Owner):

APTCH agrees to provide for the housing and care of above bird according to the terms and conditions set forth herein:

APTCH:

1. Will provide bird daily with a healthy diet of pellets supplemented with seed and nut treats, fresh fruit, pasta and veggies; Fresh water will also be provided daily.
2. Will provide an appropriately sized cage and toys for the bird if Owner does not provide them.
3. Will clean birds' cage on a daily basis.
4. Will provide out-of-cage time and exercise appropriate for the bird and as circumstances allow.
5. Will make every effort to keep Owners' bird separate from the shelter birds. However, it will be housed in a parrot shelter with many other birds and APTCH cannot make any guarantees about the continued health of Owners' bird.
6. Will facilitate and pay for a minimum of one (1) well-bird check-up per year with a licensed avian veterinarian.
7. Will notify Owner of all veterinary visits no more than one (1) week subsequent to the visit. Owners' consent for veterinary care is not required and is at the discretion of APTCH. Copies of all veterinary records and bills will be made available to Owner no more than two (2) weeks after they are incurred (Notification).
8. Will not take ownership of above bird and will return bird and items accompanying bird to Owner at any time except under circumstances described in numbers 11 and 13.

Owner:

9. Is required to give APTCH copies of records from a licensed veterinarian no more than three (3) months old showing their bird is healthy **prior to its acceptance as a Resident bird**. APTCH will not reimburse Owner for these medical expenses. If bird has never been to a vet, there is a \$75 testing fee to check for communicable diseases (testing is done through Avian Biotech).
10. Agrees to pay a monthly fee of _____ to APTCH to maintain Resident status for their bird. Fee is due on the _____ day of each month. APTCH will not send out monthly bills, so it is Owners' responsibility to make payments either in person or send them via mail to: 114 N. Main St, PO Box 246, Creston, IL 60113. APTCH is not responsible for lost or undelivered mail.
11. Agrees that if at any time during the birds' stay at APTCH Owner misses three (3) monthly payments (consecutive or non-consecutive), all their rights of ownership shall be relinquished to APTCH. APTCH will then be free to adopt the bird out to a suitable home as it sees fit.
12. Is required to sign a Medical Power of Attorney for their bird.
13. Agrees to reimburse APTCH for all veterinary expenses within one (1) month of Notification except as described in item number six (6). Right of ownership will also transfer to APTCH if veterinary bills remain unreimbursed for three (3) months after Notification.
14. May visit their bird at any reasonable time by appointment. Appointments must be made three (3) days in advance.
15. May provide APTCH with a cage, toys, food, treats and any other amenities they wish for their bird during its stay.

17. Must notify APTCH of all home address, phone number and email address changes.
