This Agreement is entered into by the undersigned Rescue and A Place to Call Home Inc.

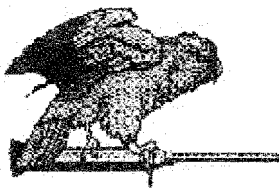
